The following persons are suggested as members of the **Advisory Committee**:

- **Thomas von Danwitz** has been a Judge at the Court of Justice of the European Union since 2006 and was President of the eighth chamber from October 2008 to October 2009. He was Professor of German public law and European law from 1996 to 2003, Dean of the Faculty of Law of the Ruhr University, Bochum from 2000 to 2001, and was Director of the Institute of Public Law and Administrative Science since 2006.
- **Jürgen Schwarze** is a Professor emeritus at the Institute of German and Comparative Public Law, European and International Law at the University of Freiburg and its former Director. He is the Chairman of the *Wissenschaftliche Gesellschaft für Europarecht* (Scientific Association for European law). Between 1994 and 1996 he was the President of FIDE (*Fédération Internationale pour le droit européen*) and currently is a member of its steering committee.
- **Lord Carnwath** has been a Justice of the UK Supreme Court since April 2012. He was a Lord Justice of Appeal since September 2001, having been a Judge of the High Court, Chancery Division, from 1994. He was Chairman of the Law Commission for England and Wales from February 1999 until July 2002. From 2004 to 2012, as Senior President of Tribunals, he led the reform of the UK Specialist Tribunal system. Previously he practised as a barrister, mainly in planning, environmental, and administrative law.
- **Michiel Scheltema** is an honorary Professor at Utrecht University. He was one of the founders of The Hague Institute for the Internationalisation of Law (HiiL), and since 2006, he has been Chairman of the Programmatic Steering Board of HiiL. He was Professor of Administrative Law at the University of Groningen from 1972 to 1997, except for 1981–1983 when he was under-Minister of Justice in the Netherlands. Since 1983, he has also been Royal Commissioner for the drafting of the General Administrative Law Act.
- **Christian Vigouroux** is the President of the Documentation and Research Division of the French Council of State (Conseil d'Etat). He held numerous positions within the French government, amongst others he was the Director of the Cabinet of the French Minister of Employment and Solidarity (2000), of the Minister of Interior (1989), of Secretary of State for Universities (1985), and more recently of French Minister of Justice Christiane Taubira (2012-2013). He was also legal advisor and Deputy Director at the Ministry of Urban Development, and General Rapporteur of the High Commission on Codification (1994-1997). He is an associate Professor at Université Paris I and at the École National d'Administration.
