# CALL FOR SUBMISSIONS

### **Purpose & Sponsor**

The Special Interest Group on Family and Succession Law of the European Law Institute (ELI Family & Succession Law SIG) is delighted to launch the first annual prize recognizing outstanding doctoral theses in Comparative Family Law, Comparative Succession Law, and Comparative or European Private International Law (in the field of family or succession), with the sponsorship of the Österreichische Notariatskammer (the Austrian Chamber of Notaries).

# **Prize & Recognition**

- Monetary Award: €500, sponsored by the Austrian Chamber of Notaries.
- The winner will be awarded the ELI F&S Law SIG Certificate of Distinction, will be mentioned on the ELI F&S Law SIG website and get the opportunity to present his/her work in an ELI F&S Law SIG webinar with an international audience

### **Eligibility**

Ph. D. already awarded by a recognized university in an EU Member state, the United Kingdom, Iceland, Norway or Switzerland between January 1st 2024 and 30th June 2025. The thesis must address one (or a combination) of Comparative Family Law, Comparative Succession Law, Comparative or European International Family Law, Comparative or European International Succession Law. The thesis must be written in one of the first five most spoken EU languages, namely: English, German, French, Italian or Spanish.

Applications will be evaluated by originality and innovation, scholarly rigor and methodology, comparative depth and intercultural awareness, practical/policy contribution, structure, clarity and academic style, source base and citation quality, critical engagement and interdisciplinary awareness.
