Dear ELI Members and Friends

It is an honour to be able to address you through this summer edition of the European Law Institute's (ELI) Newsletter. As a member of the ELI, you are part of a unique European legal community. The European Court of Human Rights plays a unique role within its own European community. It monitors respect for human rights in the 47 Council of Europe Member States that have ratified the European Convention on Human Rights. Not only citizens of those 47 Member States, but also everyone within the States' jurisdiction, may bring his or her complaint to Strasbourg.

I was particularly interested to read about your research project on Empowering European Families. If there are, as the ELI estimates, around 16 million international couples in the European Union, one can assume that this figure is even higher within the Council of Europe's legal space of 830 million Europeans. The ELI's project looks at the problems international couples are facing in relation to family and succession law. We witness some of these problems here in Strasbourg when complaints are brought to the Court by an individual, whether a mother, a father, a spouse, a grandparent or even a child, against a Respondent State.

International child abduction is a phenomenon which often arises when one parent lives in a country other than his or her country of origin. The Court has found that in these cases the obligations that the European Convention on Human Rights imposes on the Contracting States must be interpreted taking into account, in particular, the Hague Convention on the Civil Aspects of International Child Abduction of 25 October 1980. The best interests of the child are paramount for the Court.

Another area of litigation which may end in Strasbourg is international gestational surrogacy. Very interesting and thorny legal issues are raised where couples enter into gestational surrogacy contracts abroad and then bring the child back to their home country. The Court through its caselaw, like ELI through its project, is responding to new legal issues which concern international families and cross-border disputes.

I wish you a very successful Annual Conference and General Assembly in Riga this September, and will follow with interest the presentation of the final results of your Empowering European Families project.

Harriet Lansing Former President of the Uniform Law Commission (ULC)

Harriet Lansing has served as a Judge on the Minnesota Court of Appeals for 28 years and five years as a senior judge. During her tenure, she has been active in judicial education, including a decade with the Appellate Judges Institute at New York University Law School.

Following retirement, she was elected President of the ULC. She continues her ULC work on its international committees and by serving on the US Delegation to the United Nations Commission on International Trade Law (UNCITRAL) Committee on Mediated Settlements.





Lance Liebman Former Director of the American Law Institute (ALI)

Lance Liebman is Professor of Law at the Columbia Law School. He teaches and does research in the areas of employment law, property law and social welfare law.

He began his tenure in Columbia (USA) in 1991 as Dean. He stepped down as Dean in 1996 and then led the Parker School of Foreign and Comparative Law for almost 20 years.

From 1999 to 2014, he was Director of the ALI, a private American law reform organisation now approaching its 100th anniversary. Before coming to Columbia, Liebman was a professor at Harvard Law School for 21 years.



Pauliine Koskelo Finnish Judge to the European Court of Human Rights

Pauliine Koskelo is a Judge at the European Court of Human Rights. She was member (2000–2005) and President (2006–2015) of the Supreme Court of Finland.

Earlier in her career, she served the Finnish Ministry of Justice as Senior Adviser in Legislative Affairs (1985– 1995) and the European Investment Bank in senior positions at the Directorate of Legal Affairs (1995–2000). She chaired the Judicial Appointments Board of Finland (2006–2012) and was a member of the Treaty on the Functioning of the European Union (TFEU) Article 255 panel (2014–2018).

Spotlight on the ELI Projects

Projects are Central to the ELI's Ambitions of Improving the Quality of European Law

At the ELI Annual Conference 2018, all current and prospective ELI projects will be featured in panels with leading experts in the field from across the globe. Details about panel discussion can be found in the following section of our website. In this section, we provide an overview of the aims of ELI projects, both current and prospective. The ultimate beneficiaries of all ELI projects are primarily European citizens and companies, but the ripple effect goes beyond the borders of Europe.

Current Projects



Civil Procedure

The project, undertaken with the International Institute for the Unification of Private Law (UNIDROIT), seeks to reduce uncertainties for parties litigating in unfamiliar jurisdictional surroundings through the development of a model universal civil procedural code. The importance of this undertaking has been repeatedly underlined by key European bodies, including within the European Parliament.



Protection of Adults in International Situations

Today, the protection of adults (and their assets) is more frequently an issue in international scenarios. Which law should apply? Which courts should have jurisdiction to hear cases? What are the drawbacks to current rules? The answers to such questions, amongst others, are addressed by this project's team with a view to laying down a final and detailed draft text of a possible EU measure on the protection of adults in international situations.



Empowering European Families (EEF)

With over 16 million couples where at least one of the partners lives in a country other than his or her country of origin, obstacles to justice in the context of divorce, succession, etc might be faced. The EEF project seeks to address these and others, inter alia, by improving existing rules on applicable law, jurisdiction, recognition and enforcement in family and succession law as well as to promote family mediation.



Deduction of R&D Expenses

The financial crisis of 2008 has highlighted the need to find new sources of economic growth and innovation is one such underutilised sources in Europe.

As tax incentives are known to stimulate investment in research and development, the aim of the project is to elaborate a harmonised list of eligible expenses and an explanatory memorandum to aid the European Commission in drafting laws on the above.



Online Intermediary Platforms

So many of us use Airbnb, Uber and Amazon today but the dynamics of such platforms can be difficult to reconcile with the currently existing regulatory framework at EU level. Model rules which include the criteria for identifying 'platform operators' and 'suppliers' as well as their duties and obligations and rules on transparency and fairness of online reputation systems (eg ratings and reviews) are among the themes addressed by this project.



Principles for a Data Economy

The world has moved from commerce in physical goods to services and today, the data economy is a powerful lever. The law is yet to catch up in a manner that promotes certainty but does not inhibit growth or innovation in this emerging field. As data has no boundaries, ELI has partnered with its American counterpart, ALI, to produce transnational Principles that can facilitate the drafting of model agreements or provisions to be used on a voluntary basis by parties in the data economy.



Common Constitutional Traditions

The Common Constitutional Traditions in Europe project seeks to address a number of questions on a theme of rising significance. The notion is enshrined in key European legal texts and repeated in courts at the highest level in Europe (like the Court of Justice of the European Union and European Court of Human Rights) but what are common constitutional traditions in Europe? What is their nature and their relationship with national identity? How do such sources emerge as common to Member States? How can they be identified and used by courts?



Business and Human Rights

As multinational corporations continue to gain economic and social influence that rivals that of nation States, it is necessary to review their impact on human rights and in particular to ensure access to justice to victims of corporate infractions in a manner that alleviates procedural and other burdens on them and facilitates the redress of their grievances. Alongside the European Union Agency for Fundamental Rights (FRA), the ELI has embarked on identifying a range of possible draft EU regulatory and/or soft law options intended to ensure the above.

Prospective Projects



Liability in Digitalised Environments

Principles of liability and conflict of laws rules need to be adapted to a world where data is no longer located in physical jurisdictions but in clouds which may change rapidly, where damage may be caused by autonomous agents acting according to patterns derived from deep learning or by decentralised autonomous organisations. The law must move with the times and preferably anticipate inevitable trends. It is the goal of this prospective ELI project to develop transnational model rules to be used as sources of inspiration by legislators in developing rules for our modern age.



Access to Digital Assets

Immovable property was and for most private individuals still predominates one's asset. However, digital assets and electronic communications are on the rise. Digital wealth covers a very heterogeneous variety of assets such as software, cryptocurrencies, gaming equipment, online bank accounts, social media profiles, etc. Those who are now faced with the need to deal with digital assets including judges, notaries and bailiffs, would benefit from a requlatory framework on this subject. The outcome of the project is a draft legislative instrument in the form of a directive that addresses the above.



Blockchain Technology

We have all heard of crypto-currencies like Bitcoin and the 'blockchain' technology that facilitates the same. These and so-called, 'smart contracts' have a huge potential to fundamentally change many areas of private law transactions. The ELI hopes to scrutinise the legal basis for these dynamic applications with a view to developing an anticipatory legal response. In particular, the goal is to formulate a legislative guide on blockchains and smart contracts that will assist legislators and judges alike in navigating their ways through this complex field.

Best Practices in European Restructuring

Presentation of ELI Project Findings at the CODIRE Workshop in Brussels (Belgium)

The topical issue of preventive restructuring in the case of insolvency was discussed at the Conference on 'Best Practices in European Restructuring', an event organised by the University of Florence (Italy), the Humboldt Universität zu Berlin (Germany) and the Universidad Autónoma of Madrid (Spain).

The ELI was represented by Stephan Madaus, Professor of civil law, civil procedure and insolvency law at the Martin-Luther-University Halle-Witenberg (Germany) and one of the reporters of the ELI project on the Rescue of Business in Insolvency Law. Madaus was invited to discuss efficiency and best designs for 'semi-formal restructurings' in light of the ELI Instrument on the Rescue of Business in Insolvency Law.

The workshop took place in Brussels at the Centre for European Policy Studies (CEPS), on 5 July 2018 and was attended by international experts in insolvency law, members of the European Commission, academics and professionals, all of whom contributed actively to the debate. It was an important occasion for the ELI to disseminate insights from the above-mentioned ELI Instrument to the restructuring community as well as amongst lawmakers.

ELI-UNIDROIT Working Group Meeting

Meeting of the Costs Working Group in Vienna (Austria)

Eva Storskrubb, Wendy Kennett and Paul Oberhammer from the ELI-UNIDROIT Costs Working Group met in Vienna

The Costs Working Group was established in November 2015 by a decision of the Steering Committee of the joint ELI-UNIDROIT project on 'From Transnational Principles to European Rules of Civil Procedure'.

On 3 July 2018 the Costs Working Group held a meeting kindly hosted by the Dean of the Faculty of Law of the University of Vienna, Paul Oberhammer, at the premises of the University of Vienna.

The focus of the meeting was on the structure of the draft on costs. Members of the Working Group, Wendy

Kennett, Paul Oberhammer and Eva Storskrubb, discussed, among other things, the following issues: a traditional 'European rule' on costs and its principles, rules on court decisions regarding costs, the scope and amount of cost, a possible recourse and security for costs.

On 6 September 2018, a panel dedicated to this project will speak during the ELI Annual Conference in Riga. Additionally, on 26–27 November 2018, a public Conference will be held in Trier (Germany) in cooperation with the Academy of European Law (ERA).

ELI-ENCJ Statement Presented at Online Dispute Resolution Conference in Liverpool (UK)

Diana Wallis Speaks on the 'Statute Book and in Court Proceedings'

Diana Wallis, former President of the ELI and former Vice-President of the European Parliament, took part in a conference on 'Online Dispute Resolution: Justice Re-Imagined' on 27–28 June 2018 in Liverpool (UK), during which she presented the ELI-European Networks of Councils for the Judiciary (ENCJ) Statement on Alternative Dispute Resolution.

In particular, Wallis spoke during a panel on 'Online Dispute Resolution (ODR) on the Statute Book and in Court Proceedings', which focused on a review of current legislative and regulatory moves in place and prospective, promoting or otherwise impacting on the future of ODR including the European law on ODR.

This very well-attended event was a great opportunity to promote the ELI-ENCJ Statement as well as the Dispute Resolution: Beyond the Courts Conference that the ELI is organising with the ENCJ and ERA in Trier (Germany) on 9 November 2018. You can download the ELI-ENCJ Statement here.

Empowering European Families Project Close to Finalisation



The final outcome of the Empowering European Families (EEF) project, which is financed by an EU action grant under the justice programme will be presented to ELI bodies at the upcoming assembly in Riga (Latvia). ELI fellows will be given the chance to vote on the project (electronically) shortly afterwards. The project was led jointly by Katharina Boele-Woelki (Bucerius Law School and Utrecht University), Wendy Schrama (Utrecht University) and ELI President, Christiane Wendehorst (University of Vienna). The project was also conducted in cooperation with the support of the Council of the Notariats of the European Union (CNUE).



The ELI Enters Into Dialogue with **National Ministries of Justice**

ELI President Christiane Wendehorst Initiates Relation-Building with Key National Stakeholders in Europe

The ELI is currently entering into dialoques with national Ministries of Justice to inform them about the work of the ELI and also about the outcome of the ELI's 'Empowering European Families (EEF)' project.

As one of the project's Reporters, ELI President, Christiane Wendehorst, has already visited Sofia (Bulgaria) and meetings in Bucharest (Romania), Budapest (Hungary) and Ljubljana (Slovenia) are also scheduled with the respective Ministers of Justice as well

as with presidents of Constitutional Courts, Administrative Courts and national Bar Associations.

The meetings are not only intended to solicit the input of the above on the project's current drafts and to ascertain how the drafts would work in practice in the above jurisdictions, but also constitute opportunities to present the ELI's work and discuss the various possibilities open for cooperation between the institutes visited and the ELL

> Given Velchey's acclaim as a renowned academic in this field, Wendehorst was particularly pleased to have had the opportunity to elaborate on the ELI's project on Common Constitutional Traditions in Europe. This project seeks to identify the source of Common Constitutional Traditions in Europe; their content; their relationship with national identity; whether they are an autonomous source of European law and the way in which they emerge as common to Member States and are expressed as such.

> After her meeting with Velchev, Wendehorst was subsequently hosted by Vladislav Slavov, President of the Union of Bulgarian Jurists. Among other themes, the two shared information on how their respective organisations are financed, the role of members in the running of their organisations and ways to encourage more active participation in key events.

Cross-Atlantic Relation Building with the ULC

A meeting of the Uniform Law Commission (ULC, also known as the National Conference of Commissioners on Uniform State Laws) took place on 20-26 July 2018 in Louisville (USA). ELI Vice-President, Sjef van Erp, elaborated on the role of the ELI, recent developments in ELI projects as well as on the Institute's ambitious goals. He also participated in various sessions, including on the Uniform Criminal Records Accuracy Act, on the Civil Remedies for Unauthorised Disclosure of Intimate Images Act, on the Electronic Wills Act, on Tort Law relating to the Drones Act as well as on the Highly Automated Vehicles Act. The ELI is proud to have Harriet Lansing, Former President of the ULC, deliver a keynote speech at its Annual Conference and General Assembly in Riga (Latvia) this year.



ELI Vice-President van Erp Represents the ELI at the Trans Europe Experts (TEE) General Assembly in Paris (France)

Trans Europe Experts (TEE) is an association created in 2009 with the dual aim of creating a network of various universities (French and international), practitioners of law, politics, economics and representatives of NGOs and other organisations and ensuring the participation of everyone in the development of European law. ELI Vice-President, Sjef van Erp, took part in the TEE General Assembly on 25 June 2018.



Legal Symposium on the Future of the EU in Alpbach (Austria)

The European Forum Alpbach is a renown discussion-forum where international academics and practitioners meet to discuss topical questions in the impressive surroundings of the Austrian Alps. This year's motto, 'Diversity and Resilience' was also reflected by the panels at the Legal Symposium.

On 28 July 2018, ELI President, Christiane Wendehorst, chaired a panel on the topic of 'The Future of the EU: The Challenges of Self-Determination'. The panellists examined which legal challenges follow on from mounting calls for national self-determination, particularly given the context of contemporary separatist movements.

Thought Exchange with Students

ELI President Christiane Wendehorst opened the 70th Summer University of the University of Vienna in Strobl (Austria) on 15 July 2018.

Strobl, situated at one of Austria's most beautiful lakes, is an inspiring place to be, especially in the summertime. Around 100 international students from 22 nations participated in an interdisciplinary thought exchange. The 70th Summer University raised the question: 'Towards a European Legal Community?' In her opening speech, Wendehorst introduced the ELI and its activities and talked about the role of a common EU legislation and its daily-life impact for EU citizens.

The Business & Financial SIG is proud to announce that its Green Paper on 'The Current Challenges for EU Company and Financial Law and Regulation' was published, *independently of the ELI*, by the above SIG. The publication is available for free download <u>here</u>.

Abstract

European company and financial law and regulation have been evolving over time along with business and financial practices. The resulting 'social licence' established by company and financial law and regulation aimed to balance the granted privileges of limited liability and share transferability with the corporate social contribution to economic development and employment. Recent transformations driven by shareholder value and financialisation have been challenging this balance of interests between stakeholders (including employees and shareholders) and society. The EU institutional framework may respond to these challenges by reaffirming the centrality of the enterprise as a going concern. On this basis, corporate accountability and responsibility may be enforced to make ongoing corporate affairs accountable and responsible for their contribution to economy and society. Ongoing corporate capacity to cope with social and environmental responsibilities may be assured along with the fair and sustainable remuneration of stakeholders, including shareholding investors, and a fair tax contribution.
