Human Rights, Democracy and the Rule of Law

Dear ELI Members and Friends,

It is my great pleasure, as President of the European Court of Human Rights, to continue the tradition of contributing to the European Law Institute (ELI)'s Newsletter.

This edition of the ELI newsletter falls during a period in European history when the relative peace and security which we have taken for granted on our continent has been shattered.

When we celebrated the European Convention on Human Rights' 70th anniversary in 2020, we highlighted that the Convention constituted one of the greatest peace projects in human history. Indeed, the very Preamble to the Convention refers to human rights and fundamental freedoms as the foundation of justice and peace in the world. The work of the Council of Europe and its judicial control mechanism, the European Court of Human Rights, has contributed to the stability, security and peace in Europe through its work on human rights, democracy and the rule of law. What role will it play in the future? My firm view is that the Council of Europe has and will continue to play an essential role in protecting human rights and fundamental freedoms to pave the way for peace in Europe again.

In particular, the European Court of Human Rights ensures the maintenance of a pluralistic democracy by guaranteeing respect for basic democratic principles in areas such as participation in free elections, freedom of expression, religion, association and assembly, and non-discrimination. It promotes the rule of law, which provides the essential framework for the development of effective political democracy. ELI's current projects on the rule of law in the 21st century, in particular on the independence of the judiciary, demonstrate your understanding of the key link between a rules based order and peace in Europe. For it is when individual freedoms are eroded that we see the catastrophic consequences of unbridled totalitarianism and violence which we are now witnessing.

Ultimately, and as the ELI Council emphasised in their Resolution on Ukraine of 24 February 2022, international law principles must prevail over violence. I very much support ELI's work in creating a vigorous European legal community because as I have had the opportunity of underlining recently, lawyers act as guardians of the rule of law by upholding their clients' fundamental rights and the fair administration of justice in general; by playing a key role as intermediaries between the public and the courts, and as actors within the Convention system by pleading the European Convention on Human Rights before national courts.

Together let us build on the achievements of the past to strengthen European legal integration in the face of atrocities and war.

Use of Digital Assets as a Security

Digitisation is rapidly changing the economic as well as the socio-political landscape. The Corona crisis has even sped up this development. Hence, it comes as no surprise that legal questions relating to digital assets have become increasingly predominant.

'Digital assets' are a term for which the precise definition as well as the applicable law is yet to be determined. There are a number of international initiatives striving to contribute to the development of law in this area. Two of those are by International Institute for the Unification of Private Law (UNIDROIT) Working Group for Digital Assets and Private Law and the EU's co-funded ELI Project on Access to Digital Assets, which have a partly overlapping scope.

The UNIDROIT Working Group for Digital Assets and Private Law was established as part of the 2020–2022 Triennial Work Programme, with the very broad objective of developing a future legal instrument containing principles and legislative guidance in this area. The current proposal states that digital asset means an electronic record which is capable of being subject to control. Control means the (exclusive) ability to change the control of that digital asset to another person and to obtain the benefit (and prevent others from obtaining the benefit) from such digital asset. In short: a digital asset requires some proprietary, exclusive nature. This

distinguishes it from digital content which may be copied or otherwise arbitrarily reproduced so that it lacks an inherent value.

Similarly, the ELI Principles on the Use of Digital Assets as Security define digital assets as any record or representation of value which is exclusively stored, displayed and administered electronically, capable of being subject to a right of control, enjoyment or use and capable of being transferred. Control includes the legal power or factual capability to deal in or extinguish such asset. [The main difference between it and the current draft of the UNIDROIT model law is that it refers to the 'right of' control rather than mere factual control, as well as legal power or factual capability.]

The UNIDROIT model law proposes to consider solely factual control in order to overcome the differences of the various legal instruments creating ownership, property rights or other interests in assets according to national laws. In fact, many countries like eg Germany do not acknowledge any absolute right in digital assets at all. German law recognises digital assets as something comparable to knowhow: you may sell it (which means that you are required to grant access to it) but if you 'lose' it, you may not claim it back. There is no ownership, protected by law, in digital assets for the time being which creates a myriad of issues.

One of those problem is that the creation of a security interest in such unrecognised assets cannot create any *in rem* rights for the (to be) protected creditor. The security interest may not be perfected in such sense that it may take effect against third parties. Therefore, Germany does not seem preferable compared to jurisdictions acknowledging an *in rem* right in digital assets and consequently most likely also the creation of a perfected security interest.

The ELI Principles on the Use of Digital Assets as Security propose that initially the law of the jurisdiction applies in which the security provider has its place of business, administration or residence. Exemptions are enumerated for digital assets which are clearly connected to a particular jurisdiction (for which that jurisdiction shall apply) or which represent ...it is of utmost importance that international institutions make an effort to facilitate such research and discussions within expert groups in order to advance and harmonise the applicable (national) legal frameworks.

a real-word asset (for which the jurisdiction of such real-world asset shall apply). However, the Principles do not seem to permit an initial choice of law which could assist with creating clarity about the applicable jurisdiction and enable holders of digital assets to choose the jurisdiction which actually created an effective legal regime for this new type of asset. The UNIDROIT model law even recommends the incentivisation of such a choice of law.

These examples demonstrate that research relating to the new phenomenon of digital assets is just kicking off. Digital assets are not tied to geographic regions but are cross border by their very nature. Hence, it is of utmost importance that international institutions make an effort to facilitate such research and discussions within expert groups in order to advance and harmonise the applicable (national) legal frameworks. The ELI project as well as the UNIDROIT working group - which had been created simultaneously and are both ongoing - contribute to that important task.

ELI Adopts Principles on the Use of Digital Assets as Security

The new ELI Principles provide guidance to private parties, whether natural or legal, contemplating the use of digital assets as security.

Despite the fact that digital assets only account, at present, for a very small share of most private individuals' asset portfolios, their popularity is on the rise. Digital assets cover a wide variety of assets, such as cryptocurrencies, stablecoins, social media profiles and online gaming accounts; whilst there is no comprehensive definition at present, guidance is desirable, inter alia on their use as security. The ELI Principles seek to provide this guidance, by setting out key concepts relevant to the use of digital assets as security. In particular, the Principles focus on situations where security providers secure the performance of their obligations visà-vis security takers by using digital assets as collateral under the terms of a security agreement.

The Principles also propose ways to identify the law applicable to the creation of security interests in digital assets, and address issues of relevance to the effectiveness of security interests in digital assets against third parties, as well as the enforcement and extinction of security interests in digital assets.

ELI Adopts a Report on Freedom of Expression as a Common Constitutional Tradition in Europe



The ELI Report summarises the current laws in EU Member States on freedom of expression. It draws from national reports submitted by experts from key jurisdictions. It is intended as a practical tool (checklist) to assist practitioners, judges and public officials in identifying commonalities and differences in the legal approaches to the main issues relating to the freedom of expression.

The ELI Report provides the analysis with respect to several topics pertaining to this field, such as unprotected speech, minority rights, speech with a religious dimension, freedom of information and of the press and media pluralism, among others. The Report is timely, as the checklist can be used to verify compliance with constitutional traditions common to the Member States in this field, and by way of contrast to understand some of the differences. In particular, as a practical tool, it can help legal practitioners to verify if a certain case or situation affecting freedom of expression can be placed inside or outside the boundaries of constitutional traditions, common to the Member States. This can also be used potentially in the context of implementing the rule of law as a condition to access to EU funds.

Protection of Vulnerable Adults: Response to the European Commission's Public Consultation

On 29 March 2022, ELI submitted a response to the European Commission's public consultation on the Initiative on the Cross-Border Protection of Vulnerable Adults.

The cross-border protection of vulnerable adults remains an important legal issue, especially in light of Europe's ageing population and the increasing mobility of people and their assets.

The ELI response, which is available <u>here</u>, builds on ELI's <u>Report</u> on the Protection of Adults in International Situations of 2020. The response reiterates the need for action in the above field, in light of the lack of uniform substantive and procedural rules at national level and inconsistent private international law rules in the field, the latter owing in part to

the limited number of signatories to the Hague Convention on the International Protection of Adults.

The response was drafted under the leadership of Christiana Fountoulakis (ELI Council Member; Professor, University of Fribourg) and Gerald Mäsch (Professor, University of Münster), in cooperation with Elena Bargelli (ELI Member; Professor, University of Pisa), Pietro Franzina (ELI Member; Professor, Catholic University of the Sacred Heart) and Adrian Ward (ELI Member; national and international expert in adult incapacity law). ELI is deeply indebted to the authors of the response.

Sustainable Consumption of Goods: Response to the European Commission's Public Consultation

On 5 April 2022, ELI submitted a response to the European Commission's Public Consultation on the Sustainable Consumption of Goods – Promoting the Right to Repair and Reuse.

The European Commission pledged in its communication of 11 December 2019 on the European Green Deal to put sustainability and the well-being of citizens at the centre of economic policy. Its current consultation was launched to solicit feedback on the 'right to repair' and how to incentivise both customers and businesses to foster the sustainable production of products and use.

ELI's Response, which is available <u>here</u>, provides several recommendations on the above questions. It was presented and discussed at the webinar of 27

April 2022. More information about the webinar, as well as the recording are available <u>here</u>. The event provided an opportunity to reflect on the broader topic of the sustainable consumption of goods, including, for example, proposals to make sustainable products the norm in the EU, boost circular business models and empower consumers for the green transition, as announced by the Commission in March 2022, as well as to examine further necessary steps for a more efficient and sustainable economy.

Launch of the ELI Ukrainian Hub

The University of Vienna and ELI Extend Cooperation Agreement

On 28 March 2022, Rector of the University of Vienna, o Univ-Prof Dipl-Ing Dr techn Dr hc Heinz Engl, and President of the ELI, Prof Dr Pascal Pichonnaz, signed an official four-year extension of their joint Framework Cooperation Agreement.

The signing of the agreement by Rector Engl and ELI President Pichonnaz took place in presence of Vice-Rector of the University of Vienna, Prof Dr Jean-Robert Tyran, former ELI President and current ELI Scientific Director, Prof Dr Christiane Wendehorst, as well as ELI's Secretary General, Dr Vanessa Wilcox.

The agreement comes months after ELI celebrated a significant milestone, its Decennial; an event that attracted prominent personalities such as Koen Lenaerts (President of the Court of Justice of the European Union), Robert Spano (President of the European Court of Human Rights) and Didier Reynders (European Commissioner for Justice). On the occasion, Rector Engl underlined the importance of the close relationship the University of Vienna and its Law Faculty enjoy with ELI, pointing among other things to the involvement of many of its staff members in ELI's high-profile projects. ELI also values this relationship immensely, not only in light of the financial support it receives but also for the stability and prospects of growth that it brings.

As he signed the agreement, Rector Engl remarked that: 'The University of Vienna and in particular the Faculty of Law are eager to be intensively involved in the existing cooperation and to be able to make appropriate use of the possibilities of Europe-wide networking.'

President Pichonnaz spoke on behalf of the Executive Committee, saying that in 2011, when ELI was founded, its administrative seat was chosen through a public tender. The University of Vienna, with its renown and



its commitment to supporting ELI for the long run, convinced those tasked to decide on the fate of ELI's seat. The signing of the extension of the Framework Cooperation Agreement for another four years (from 2023-2027) today is yet another confirmation not only that initial promises were kept, but also that the mutual interests of both parties under this arrangement are aligned. It is therefore with great pleasure that ELI, and in particular its Executive Committee, acknowledges the renewed commitment of the University of Vienna towards ELI. Despite the difficult times in Europe, or more precisely, because of the difficulties Europe and the world at large are witnessing, it is of utmost importance that this extended Framework Cooperation Agreement is signed today, with a view to enhancing ELI's potential of strengthening its resilient community of jurists. Fundamental principles and the rule of law in Europe need reaffirming; Europe needs to gear up for the digital age and the existential threats of climate change

and environmental degradation must be addressed. These are some of tasks that ELI, thanks to the support of the University of Vienna, has and continues to tackle with its membership of close to 2,000 leading lawyers, judges, academics and other legal professionals from across Europe and beyond.

At ELI's 2021 Annual Conference, Federal President of the Republic of Austria, Alexander Van der Bellen, observed in his opening speech that it is because of the confidence the University of Vienna had and has in ELI that Austria is at the centre of the most important legal discussions. Like him, ELI is 'proud' that Austria, and more specifically, the University of Vienna, is its host. Above all, ELI warmly thanks Rector Engl and everyone else at the University that have spoken in its favour. It looks forward to continuing to strengthen ties with the University and to building on this collaboration with a view to improving the quality of law in Europe.
