REQUIREMENTS FOR FORMATION OF THE REPORTS

- Volume - 4 pages in A4 format page (297*210 mm), orientation - portrait;
- Margins: top, bottom, right, left - 20 mm;
- Font - Times New Roman, pins - 14, line spacing - 1.5, Style - Normal;
- References should be made in square brackets; list of references is noted at the end of the text without repetitions (eg. [2, p. 35]: 2 – is a number of the source and 35 – is a number of the page);
- First line - (font bold italics, aligned on the right side), name and surname of the author;
- Second line - (italic type, the way to the right) scientific degree, position / year of the study and university (double paragraph);
- Next paragraph - (all lowercase bold font, centered) theme of the report;
- Text of the report;
- At the end of the text of the report – references.
